## 12 Statistics You Must Know

- 1. Alcohol impaired driving fatalities accounted for **32**% of the total motor vehicle traffic fatalities in the United States.
- 2. Research indicates that talking on a cell phone, even if its hands free, drains the brain energy for driving safely **by 39**%.
- 3. In fatal crashes involving young novice drivers almost 50% of those killed are **passengers of the novice driver**.
- 4. For 16 year olds the risk of a fatal crash involvement increases more than **150%** if three or more passengers are present.
- 5. The vast majority of fatal crashes involving young drivers are in **fair weather and dry roads.**
- 6. **3%** of young driver fatal crashes were rear-ended collisions.
- 7. A majority of young driver fatal crashes in Michigan were on a **rural** roadways.
- 8. A young driver's risk of being in a traffic crash is at a lifetime high during the first **six months** of driving.
- 9. Drivers who use cell phones are **4 times more likely** to be involved in a crash than drivers who are not using cell phones.
- 10. The months of **May, June, July**, account for approximately one-third of all young driver crashes in Michigan.
- 11. For every 500 miles driven, the average driver has at least 1 near collision.
- 12. 10% of young driver fatal crashes occur in the rain.

### Graduated Driver's License Level 2 Restrictions

Graduated Driver License Level 2 restrictions have changed. Michigan Public Act 124 of 2011 amends the changes that were made in March 2011 and makes these new restrictions effective July 20, 2011. Under the recent changes, GDL Level 2 licensed drivers:

- 1. Shall not operate a motor vehicle between 10 p.m. and 5 a.m. except when:
  - driving to or from or in the course of employment;
  - driving to or from an authorized activity; or
  - accompanied by a parent or legal guardian or a licensed driver 21 years of age or older designated by the parent or legal guardian.
- 2. Shall not operate a motor vehicle at any time with more than 1 passenger in the vehicle who is less than 21 years of age except:
  - when the additional passengers are immediate family members;
  - when driving to or from or in the course of employment;
  - while going to or from an authorized activity; or
  - when accompanied by a parent or legal guardian or a licensed driver 21 years of age or older designated by the parent or legal guardian.

Authorized activity means any of the following:

- a) A school or a school-sanctioned event or activity. School means a public or private school, including a home school
- b) A sporting event or activity, or extracurricular event or activity, that is not school-sanctioned but that is part of an official sports league or association or an official extracurricular club, or that is paid for as a service offered by a business specializing in those events or activities or training for those events or activities.
- c) A class or program of vocational instruction offered by a college, community college, nonprofit association, or unit of government or by a business specializing in vocational training.
- d) An event or activity sponsored by a religious organization that is tax-exempt under federal law
- e) Transporting an individual in need of immediate emergency care or personal protection to a health care professional, hospital, police station, domestic violence shelter, or public safety location.

# Kelsey's Law

Level 1 and Level 2 License holders under the Graduated Driver Licensing program are prohibited from using a cell phone while driving. Violations will be a civil infraction and fees associated with the original ticket may be up to \$240.Exemptions are:(1) Using a voice-operated system integrated into the vehicle. (2) Reporting a traffic crash, medical emergency, or serious road hazard. (3) Reporting a situation if the person believes his or her personal safety is in jeopardy.
